# Supervisor of Loyola Law Clinic's Family Law Section

- -Supervised senior law student practitioners in the Family Law Section of Loyola's Law Clinic in Orleans, Jefferson, St. Bernard, St. Tammany, Plaquemines, and St. Charles Parish Courts. (Fall 2002 through Fall 2023)
- -Represented over 700 indigent clients in law clinic cases.
- -Supervised the representation of over 100 children in court appointed custody cases. (2003-2023)
- -Partnered with Families Helping Families by representing parents with special needs children between the ages of 15 and 17 by filing for Continuing Tutorships. (Spring 2015 -Summer 2023)
- -Supervised the representation of interdicts in Interdiction cases. (2008-2023)
- -Supervised the representation of three young girls in a nonparent custody case with allegations of drug abuse and domestic violence. After 13 scheduled trial dates, the nonparents dismissed their intervention. The student practitioners gave opening statements and closing arguments, qualified the child custody expert witness, actively participated in all court conferences and pre-trial conferences, elicited testimony from the litigants, and admitted exhbits. The students logged over 1,000 hours. (Spring 2022 Spring 2023)
- -Supervised the representation of a young teenager in a grandparent custody and abuse case. The student practitioners were successful in gaining a permanent protective order

for the child against the abuser. (Fall 2021 – Spring 2023)

- -Supervised a custody case in St. Tammany Parish. Hurricane Ida made landfall on August 29, 2021, leaving a wake of devastation and destruction in Southeastern Louisiana. Not only were homes lost and families displaced, but the Hurricane gave rise to a multitude of child custody issues and family law disputes exacerbated by evacuations out of state, lack of resources, and minimal contact between parents. A Mother retained the Family Law Clinic in early September whose daughter was taken out of state during the Hurricane Ida evacuation by her father. The Clinic filed a petition to establish custody on behalf of the client, and prayed for the immediate return of the child, as a repercussion for the father's violation of the Louisiana Relocation Statutes. Under the Relocation Statutes, improper relocation, including failure to provide notice of a proposed relocation of a child, is grounds for immediate return of the child back to their home state and home parish. After multiple hearings, the Judge ordered the immediate return of the child to the State of Louisiana. After five months apart, the client and her daughter were finally reunited in Louisiana and are happy to be making memories together again. (Fall 2021 Spring 2022)
- -Partnered with Jefferson Parish Senior Services in providing legal assistance to senior citizens. (Fall 2021 Spring 2022)
- -Supervised Paternity case in both Jefferson Parish Juvenile Court and the 24th Judicial District Court for the Parish of Jefferson. The Father of a minor child owed over \$ 10,000 in child support arrears when he found out that he was not the biological father. A DNA paternity test confirmed that he was not the father. The clinic obtained a Judgment of Non-Paternity and had his child support obligation terminated. (Spring 2020)
- -Supervised two Post Hurricane Katrina-Louisiana Road Home cases and successfully resolved the issues in the 2020 Spring Semester, almost fifteen years after Hurricane Katrina. One client began receiving letters and notices in August 2013 from the State of Louisiana stating that he was overpaid \$23,000.00 and must repay the money. For years, the student practitioners corresponded with the attorneys for Office of Community Development-Disaster Recovery Unit and researched and reviewed hundreds of pages of documents. A year ago, a student noticed discrepancies with the original FEMA documents that used inaccurate building and contents coverage dollar amounts and reported the misinformation. Finally, in 2020, the law firm handling the collection of overpayments acknowledged the error and closed the recovery file, thus ending the Road Home nightmare for our client. In our second Louisiana Road Home case, the Family Law Section, in early 2018, collaborated with Clinical Professor Davida Finger and the Community Justice Section in a case involving a proof of ownership issue for our client. The State wanted \$86,000.00 back from our client. The student practitioners filed suit

and were successful at trial. Finally, in 2020, all paperwork is completed and the Road Home nightmare for our client will be ended. (Fall 2013 - Spring 2020)

- -Supervised student practitioners representing a child in a grandparent visitation case on appeal to the Fifth Circuit Court of Appeal. The students filed a brief and orally argued the case. The Fifth Circuit affirmed the 24th Judicial District Court's judgment which was the clinic's position and remanded to set the visitation terms. Previously, student practitioners filed two legal memorandums and orally argued twice before the district judge and won both arguments on the correct law and the legal standard of proof (preponderance of the evidence versus clear and convincing) to be used in trial. The students also examined and cross-examined many witnesses including qualifying the expert during a three day trial. (Spring 2018 Fall 2019)
- -Supervised the representation of a minor child in a three day grandparent visitation trial. The student practitioners made seven court appearances including a hearing officer conference, status conference, two days of oral arguments, and the three day trial. The students also wrote and filed two Legal Memorandums on the appropriate law and the proper standard of proof. (Spring 2018)
- -Supervised the representation of a special needs minor child in a two day non-parent custody trial. (Spring 2018)
- -Supervised the representation of minor children in a two day trial where the student practitioners examined five court appointed expert witnesses and the children's therapist. The Court conducted "Watermeier" hearings and rendered a Considered Decree at the end of trial with the Court awarding the Court domiciliary status of the children instead of the parents. This case took three years to complete with a total of ten clinic students throughout the years logging collectively over 700 hours. The landmark case, Watermeier v. Watermeier, defines how minor children are examined by the Judge with the attorneys and court reporter present. (Fall 2014 Spring 2017)
- -Supervised the representation of a grandfather gaining visitation rights of his 2-year-old grandchild after her mother was shot and killed. (Spring 2017)
- -Supervised the representation of a father where the law clinic was successful in gaining sole custody of his minor child. (Spring 2016)
- -Supervised the representation of a three-year-old in a custody case. This case involved many issues, including, but not limited to, alleged domestic violence, alleged child abuse, and alleged inappropriate use of social media. The student practitioner appeared in court multiple times, filed a Legal Memorandum, and prepared a comprehensive superlative trial notebook. (Spring 2016)

- -Supervised the representation of minor children in a five hour non-stop non-parent and parent custody contested trial with seven litigants. (Fall 2015)
- -Supervised our first LBGT case in a full day custody trial. The student practitioners met the client, filed a legal memorandum, prepared for trial and went to trial in a week's time. They examined and cross-examined four witnesses including the expert witness, a custody evaluator, and gave a closing argument. (Spring 2015)
- Supervised the representation of a grandparent in a visitation case. Under LRS 9:344, a grandparent whose child is deceased may be awarded visitation with the grandchild. The student practitioners examined seven witnesses and won their case. (Spring 2015)
- -Supervised the representation of a great grandmother in a Contempt of Court visitation hearing. The student practitioners negotiated a consent judgment and the contempt proceedings against their client were dismissed with prejudice. (Fall 2014)
- -Supervised the representation of a ninety-one year old client in two civil cases, a contested succession and property partition, and was successful in not having the client evicted from her home. (Spring 2014)
- -Supervised the representation of minor children with multiple parents in an eight hour grandparent custody trial. The student practitioners participated in two "Watermeier" hearings where the Judge interviewed two of the minor children. (Spring 2014)
- -Supervised the representation of a mother and successfully obtained a judgment for their client in a custody and community property debt case. (Spring 2014)
- -Supervised the representation of a wife where the student practitioners obtained a divorce and final periodic spousal support award for their client after a trial on the merits. (Spring 2014)
- -Supervised the representation of a deployed Army soldier in Afghanistan in a military child custody case where the student practitioners were successful in gaining a custody order by using a Power of Attorney signed by the soldier in court the day before he deployed. (Spring and Fall 2013)

- -Supervised the representation of non-parents in a custody trial that went to trial with seven attorneys and six witnesses where the mother was an invalid at a convalescent home. The student practitioners were able to overcome the high burden of proving that

joint or sole custody to either parent would result in substantial harm to the child, as per La. Civil Code article 133 and their clients were awarded sole custody. (Spring 2013)

- -Supervised the representation of a young mother and successfully regained custody of the child for the mother after not having custody for over a year. (Fall 2012 Spring 2013)
- Supervised the representation of a father and successfully gained provisional custody for their client in an interstate custody case pending DNA paternity testing results. (Fall 2012)
- -Supervised the representation of a young father in a highly litigated custody case for two years. Against all odds, the student practitioners won the custody trial. Prior to the trial, a mental health professional examined the parents in a court ordered custody evaluation according with the best interests of the child factors. The student practitioners filed a Petition and numerous Motions; argued before the Court on their Motions; conducted formal discovery; prepared witness and exhibit lists; hosted numerous settlement conferences before the trial date; and prepared a trial notebook. At the trial, the students examined the father and cross examined the mother and the custody evaluator. Even though the custody evaluator testified that the mother should be designated the domiciliary parent, the Court granted our client domiciliary status of the parties' young child. This Judgment is a considered degree because a trial was conducted with the judge considering all evidence, including the testimony of the witnesses and exhibits offered into the court record. The Bergeron Standard is now applied to this case which means that the parent attempting to change custody in the future has the heavy burden of proving that the continuation of the present custody is so deleterious to the child as to justify a modification of the custody decree or proving by clear and convincing evidence that the harm likely to be caused by a change of custody is substantially outweighed by the advantages to the child. (Fall 2010 - Spring 2012)
- -Supervised the first successful SIJS clinic case where our client, the mother, was awarded a custody judgment in the 24<sup>th</sup> Judicial District Court allowing her minor child to petition for "Special Immigrant Juvenile Status". The Immigration, Community Justice, and Family Law sections of Loyola Law Clinic collaborated to represent abused, neglected, and abandoned minors and their caretakers. Under a recently enacted federal law, there is protection for special immigrant children who face extreme hardships because of the acts of one or both parents. Federal law allows these immigrant children to begin the road to full U.S. citizenship. Law Clinic students worked for two years to research the law, interview the youth and their guardians, prepare pleadings, and represent the children and their caretakers in court. The minor had fled from El Salvador where he was abandoned by his father and harassed and abused by gang members in retaliation for refusing to join. Cheryl Buchert and student practitioner, Laken Davis,

- spearheaded this first successful case. They collaborated with other student practitioners supervised by Professors Hiroko Kusuda and Davida Finger, Staff Attorney Laila Hlass, and Immigrant Outreach Coordinator Rebeca Zuniga-Hamlin. (Fall 2010 and Spring 2011)
- -Supervised writing requirement of a law student at Loyola University College of Law. (Summer 2009)
